Fund description

The Fund invests in a mix of shares, bonds, property, commodities and cash. The Fund may buy assets outside the common monetary area (CMA) up to a maximum of 35% of the Fund (with an additional 5% for Africa ex- CMA). The Fund typically invests the bulk of its foreign ex-Africa allowance in a mix of funds managed by Orbis Investment Management Limited, our offshore investment partner. The maximum net equity exposure of the Fund is 75% and we may use exchange-traded derivative contracts on stock market indices to reduce net equity exposure from time to time. The Fund is managed to comply with Regulation 28 of the Namibian Pension Funds Act. Returns are likely to be less volatile than those of an equity-only fund.

Fund objective and benchmark

The Fund aims to earn a higher total rate of return than that of the average Namibian retirement fund investment manager over the long term. The benchmark is the return of a daily weighted average index of Namibian multi asset class funds that comply with the limits governing Namibian retirement funds.

How we aim to achieve the Fund's objective

We seek to buy shares at a discount to their intrinsic value. We thoroughly research companies to assess their intrinsic value from a long-term perspective. This long-term perspective enables us to buy shares which are shunned by the stock market because of their unexciting or poor short-term prospects, but which are relatively attractively priced if one looks to the long term. If the stock market offers few attractive shares we may increase the Fund's weighting to alternative assets such as bonds, property, commodities and cash, or we may partially hedge the Fund's stock market exposure. By varying the Fund's exposure to these different asset classes over time, we seek to enhance the Fund's long-term returns and to manage its risk. The Fund's bond and money market investments are actively managed.

Suitable for those investors who

- Seek steady long-term capital growth
- Are comfortable with taking on some risk of market fluctuation and potential capital loss, but typically less than that of an equity fund
- Wish to invest in a unit trust that complies with retirement fund investment limits
- Typically have an investment horizon of more than three years

Annual management fee

Allan Gray charges a fee on the portion of the fund they manage, excluding the portion invested in Orbis funds. The fee rate is calculated daily by comparing the Fund's total performance over the last two years to that of the benchmark.

Fee for performance equal to the Fund's benchmark: 1.00% p.a.*
For each percentage of two-year performance above or below the benchmark we add or deduct 0.1%, subject to the following limits:

Maximum fee: 1.50% p.a.*
Minimum fee: 0.50% p.a.*

This means that Allan Gray shares in approximately 20% of annualised performance relative to the benchmark.

A portion of the Fund may be invested in Orbis funds. Orbis charges performance-based fees within these funds that are calculated based on each Orbis fund's performance relative to its own benchmark.

Total expense ratio (TER) and Transaction costs

The annual management fees charged by both Allan Gray and Orbis are included in the TER. The TER is a measure of actual expenses incurred by a fund over a 3-year period (annualised). Since Fund returns are quoted after deduction of these expenses, the TER should not be deducted from the published returns (refer to page 2 for further information). Transaction costs are disclosed separately.

Fund manager quarterly commentary as at 31 December 2016

Equity, fixed interest and offshore all contributed positively to the Fund's 3.4% total return for the year. Returns for most asset classes were modest, especially compared to the returns of the previous 5, 10 or even 15 years. The FTSE/JSE All Share Index (ALSI) returned 2.6% for the year, the NSX Overall Index advanced by 31.4%, while the MSCI World Index rose 8.5% in US dollars but declined 3.8% in Namibian dollars. The standout for the year was the JSE All Bond Index, which returned 15.5%. Small moves in the headline indices mask substantial moves in the underlying investments. The Resources Index returned 34.2% while the Industrials Index had its first down year since 2008, falling 6.6%. This contributed handsomely to the NSX Overall Index, which has a material weighting to resources. The Orbis funds had a great year relative to international benchmarks – but this was offset by the stronger Namibian dollar.

Despite South African equity markets being more-or-less flat over the past two years, we are still cautious. Valuations are down, but from a high level compared to historic metrics and what we consider to be fair value. We think the majority of companies are overvalued rather than undervalued. This informs the Fund's 41.4% exposure to South African and Namibian equities and total equity exposure of 57.4%. Meanwhile, the Namibian economy remains fairly muted, exacerbated by a technical recession. Taking into account the contractionary budget announced by the Ministry of Finance, and the continuing drought, 2017 will likely be a challenging year for the economy.

The Fund had individual shares that contributed strongly to performance and others that were significant detractors. The good thing about the detractors is that our estimates of fair value have not changed; lower prices mean greater margins of safety and additional upside potential. We have reduced exposure to some winners, such as banking stocks, as they approached fair value, and added to underperforming positions. Increased exposure to the, now cheaper, laggards should help the Fund deliver good returns.

An example of a share we added to is Sasol. The low oil price and cost overruns on Sasol's Lake Charles Chemical Project (LCCP) have turned investors against the company. We agree that the LCCP cost escalations are disappointing and diminish the valuation, but not to the extent discounted by the market. Even though beneficial operation and operational cash flow from the LCCP will only begin in 2019, Sasol has smaller projects ramping up during 2017 that should contribute meaningfully to cash flow. Additionally, in our view, an oil price of US\$50 is low, which skews the risks in favour of Sasol investors. We don't expect much of an oil price recovery, but a higher price is possible despite the negative rhetoric. As the sharp price appreciation, against expectations, of industrial commodities (such as copper) in 2016 demonstrated, forecasting commodity prices is difficult. In our view, one should rather be a buyer when an industry is struggling and sentiment is poor (the oil industry currently), and a seller when the consensus is positive and an industry is booming.

The Fund is a collection of undervalued assets that we believe will yield good real returns over time. It is conservatively positioned and ready to take advantage of any opportunities. The largest net purchases over the past quarter were Naspers, British American Tobacco, and Sasol, while we reduced exposure to Sappi, Barclays Africa Group and Netcare.

We are awaiting Bank of Namibia's (BoN) final decision on this instrument's (South African or foreign) status. In the meantime, the BoN has extended the grace period for investors to rebalance their portfolios until 31 October 2018.

Total expense ratio (TER) and Transaction costs

The total expense ratio (TER) is the annualised percentage of the Fund's average assets under management that has been used to pay the Fund's actual expenses over the past three years. The TER includes the annual management fees that have been charged (both the fee at benchmark and any performance component charged) and other expenses like audit and trustee fees. Transaction costs (including brokerage, Securities Transfer Tax [STT], Share Transactions Totally Electronic [STRATE] and investor protection levies where applicable) are shown separately. Transaction costs are a necessary cost in administering the Fund and impacts Fund returns. They should not be considered in isolation as returns may be impacted by many other factors over time including market returns, the type of fund, the investment decisions of the investment manager and the TER. Since Fund returns are quoted after the deduction of these expenses, the TER and Transaction costs should not be deducted again from published returns. As collective investment scheme expenses vary, the current TER cannot be used as an indication of future TERs. A higher TER ratio does not necessarily imply a poor return, nor does a low TER imply a good return. Instead, when investing, the investment objective of the Fund should be aligned with the investor's objective and compared against the performance of fiers value for money. The sum of the TER and Transaction costs is shown as the Total investment charge.
